Main purpose of the job:	Tewkesbury area based at Central Depot, Swindon Road, Cheltenham requires Waste Collection LGV Drivers to drive vehicles to undertake collection of refuse and recyclables from properties throughout the Tewkesbury district		
Key duties and responsibilities:	This job description sets out the key outcomes required. It does not specify in detail all the activities required to achieve these outcomes.		
	 To drive the company's waste and recycling vehicles in a safe, considerate manner, following a pre-planned route in accordance with route risk assessment instructions. This will involve plenty of reversing and careful driving often along narrow streets with parked cars. To undertake daily checks of the vehicle before it is used to ensure it is in good working order. To report any vehicle defects and complete the necessary paperwork to ensure compliance with transport legislation. To assist with vehicle loading as and when required (this will depend on collection rounds). To ensure the vehicle is unloaded, re-fuelled and ready for use the following shift. All employees of Ubico are also expected to: Work to add value to, and be a valued member of, the team and to be valued by customers. Comply with the organisation's health and safety policies and safe systems of working. Work in compliance with the codes of conduct, regulations (including financial) and policies of the organisation.
